INTERNATIONAL MEMBERSHIP POLICY

Definition: "International Membership" will refer to those Members who permanently reside outside of the Republic of South Africa and have no direct ties to Rand Club. This differs from Absentee Members, who are re-categorised as such after having been a Town Member. International Members enjoy full reciprocity benefits and, when in Johannesburg, enjoy all discounts applicable to Town Members.

1. As far as possible a candidate for International Membership of Rand Club ("the Club") must be endorsed by a Member in good standing, known to them for a period of not less than one year.

2. When a candidate knows no Members of the Club, the Membership Committee, with help from the General Manager may undertake a brief introductory interview online.

International Members shall not be entitled to vote at any general and special meetings as prescribed by Rand Club Rules and Regulations.
Spousal Membership benefits shall not extend to International Members.

5. When a candidate applies for Membership from outside the Republic of South Africa ("International Member"), the following will apply:

a. The candidate will pay the administration fee, which will be charged at double the Full Town administration fee. Such fee will not be refundable.

b. The annual membership fee applicable to such a candidate will be charged at 200% of the Full Town rate.

c. Such fees will be payable upfront, and on the candidate successfully gaining Membership of the Club. d. Candidates joining after the September annual invoicing date will be charged a pro-rated amount based on the number of full months remaining.

e. Age discounts are not applicable to the International Membership category.

6. The Club will retain the right to rescind International Membership where it represents a threat to the Club of whatever nature.

7. If the Club has to rescind such International Membership, it will do so for good cause and after affording the International Member the right to be heard. 8. No fees, whether paid in advance or otherwise will be refunded save as permitted in the Club's Rules.

9. In case of doubts as to the meaning of any of the provisions of this policy, the interpretation of the Membership Committee shall be binding upon Members and Candidates.
